#### **BEFORE USING THE FLOOR**

- Do not use vapour-proof, non-skid underlays or other coverings
- Attach felt pads to the legs of chairs and tables in order to avoid scratching the finish.

#### ATTENTION!

- Vacuum or dry-mop floors regularly
- Be sure to start regular maintenance before the surface is worn through to bare wood.
- NB! Place all organic materials like cloth in a metal container filled with water for at least 16 hours to avoid self-combustion. Dispose of them according to regulations.

# SYNTEKO RE-COVER DIRECTIONS FOR USE



For periodic maintenance of floors treated with Synteko oils use **Synteko RE-COVER.** How often you use it will depend on the amount of traffi c and how often the floor is cleaned:

- normally every other year for residential areas
- approx. 2–4 times per year for commercial areas.

Regular maintenance will restore the lustre of the floor and keep it looking beautiful.

Be sure to begin regular maintenance before you wear through to the bare wood. You can also use RE-COVER for local repairing.

#### 1. PREPARATION

- Clean the floor with a Synteko REMOVER (s. separate Product Information) solution.
- Make sure the floor is completely dry before applying Synteko RE-COVER.

#### 2. APPLICATION

- Apply it thinly with a rubber spatula, floor cloth or similar.
- Allow the floor to absorb the RE-COVER for 10–15 minutes before applying it again (if necessary).
- Let the surface dry for 20 minutes.
- Polish the floor with a clean, dry, non-flocculent floor cloth.
- The floor may be used after 2–4 hours.
